How will my Year 11 child be supported to move on to Post-16?

If you are a Year 11 student, we understand that this period in your academic year is a very important time to plan your future and that normally we would be on hand at school to support you with this. We know that many of you have already made plans for when you leave school, however, some of you have not committed to this next step.

Below we have added some links to local Post 16 Providers who have courses that you may be interested in. These include the larger colleges such as Suffolk One and Suffolk New College. We have spoken to the colleges and they would like students to apply for the courses which they are interested in doing at the level which represents their predicted grades for this year. The colleges will then look at assessing students on their practical ability and through assessments to ensure they are on the right level of course.

We have also included some smaller and bespoke post 16 providers who offer full time post 16 education placements in smaller settings and also have pre apprenticeship and apprenticeship courses available. It is worth looking at these as they have many different programs such as sport and gym coaches, child care, health and social care, business studies and many other options.

What will the Corona virus bill mean for children with EHCP plans?

The draft Coronavirus Bill proposes two key amendments to the law:

- The duty to make the provision in an EHC plan (section 42 of the Children and Families Act 2014) may be amended to a 'reasonable endeavours' duty. This means the local authority would need to do whatever it reasonably can to put provision in place, but if they cannot do so they would not necessarily be breaching the law.
- The duty on schools to admit a child where the EHC plan names that school (section 43 of the Children and Families Act 2014) may be 'disapplied'

There are also changes in the Bill around the duty to provide transport and with Annual Review and reassessments.

This will give local authorities the ability to divert valuable resources to where it is needed for the shortterm. It's expected that these measures will be reviewed montly.

Are there any changes to the SEND appeal process?

If you have an appeal in progress. the current position is that this will still go ahead but will most likely be held remotely. Some appeals have already been heard using telephone or video links.

If you wish to delay your appeal due to the crisis, perhaps you are finding it difficult to gather evidence for example, you could request a postponement by using the 'request for changes' form (https://www.gov.uk/government/co llections/special-educationalneeds-and-disability-tribunal-forms)

You can still make a new appeal. The SEND Tribunal service have said they will be prioritising 'phasetransfer' appeals. A 'phase transfer' is when a child or young person is due to move up to the next phase of their education in September (primary to secondary, secondary to post-16 etc).
